- 5. The date for determining age/qualification and experience shall be the last date of submission of application form.

The engagement will be initially for a period of One year which can be extended or curtailed at the discretion of the Director, CSIR-NML based on requirement, performance and conduct of the Part-time Doctor. However, the engagement can be discontinued at any time by giving one month's prior notice by either side or by depositing one month's Honorarium in lieu thereof.
- 7. The above position is purely contractual engagement on part-time temporary basis and the selected candidate will not be entitled to stake any claim for regular appointment in this Institute.
