Sealed tenders are hereby invited in two envelop/bid system, for the below mentioned work from the Contractors working with CPWD, PWD, MES, Railways, Semi-Government Organization, Public Sector Undertakings, Tata group or those who have worked for CSIR or its laboratories/ Institutes and have successfully carried out minimum one/two/three similar works of amounting 80%/50%/40% value of estimated cost i.e. for Rs 1,79,49,207.00/Rs.1,12,18,255.00/Rs.89,74,604.00 respectively or above in a single contract during last seven years. In addition, the contractor should have experience in Replacement/ Supply, Installation, Testing & Commissioning of minimum 2x100TR capacity central AC plant.

- 1. The tender shall not be issued physically. The interested and eligible contractors are to download the complete tender/contract document from NML Website i.e <u>www.nmlindia.org</u>.
- 2. The tenderers shall be required to submit the bids in two envelopes (envelopes should superscribed with envelope no. & documents in envelope.)
 - A. <u>Envelope-1</u>:- will contain two envelopes (<u>Eligibility Criteria & Technical bid</u>)
 - (i) <u>Eligibility Criteria</u>- Will contain self-attested copies of work orders of similar nature with completion certificates/bills specified as above only, including the following:-
 - (a) Earnest Money and Tender Fee (Two Separate crossed demand drafts in favour of Director, CSIR-NML, Jamshedpur payable at State Bank of India, NML Branch, Jamshedpur) specified as above only.
 - (b) TIN/VAT registration certificate.
 - (c) PAN Card
 - (d) Banker's Certificate issued within last one year from NIT date.
 - (e) Valid electrical license (for electrical works).
 - (ii) <u>Technical bid (Part-I)</u>, including the schedule of work (without indicating the price) duly signed and acceptance of all terms and conditions & Deviations if any from NIT specifications should be clearly brought out in separate sheet. Financial implications due to such deviations should clearly brought out in the above sheet along with the technical specification, supporting documents, price breakup etc. All requisite Technical documents mentioned in the tender needs to be submitted along with the bid. Envelope -2 of tenders will not be opened and will be treated as cancelled in case Envelope -1 is found to not in order.
 - B. <u>Envelope-2</u>:- Will contain only downloaded price bid/financial bid (**Part-II**) & tender documents in complete in all respect available on <u>www.nmlindia.org</u>, failing which bid will be rejected.
- 3. Envelope-1 & 2 are to be sealed separately. Both the envelopes are to be in sealed bigger size envelope. The tenders are to be dropped in the tender box kept in the security office at the gate latest by 15:00 hrs on date:10.04.2017. In case these are sent by post these should be sent by Registered post/Speed post addressed to the Director, CSIR-National Metallurgical Laboratory, Burmamines, Jamshedpur-831007. Tenderers are to ensure that they post the tender well in advance so as to reach before the closing time and date indicated. This office will not be

responsible for postal or any other delay. Tenders/offers sent by fax/e-mail will not be entertained and shall be rejected.

- 4. The tender shall be opened on **date: 10.04.2017** at **15:30hrs**, in the presence of tenderers or their representatives, if any. Only Envelope-1 shall be opened on this date & time.
- 5. The Scrutiny/evaluation technical bid shall be done by CSIR-NML, in consultation with any agency as deemed necessary. In case it is found that the technical cum commercial bid of a tenderer is not in line with NIT requirements/or contains many deviations, CSIR-NML reserves the right to reject the technical bid of the firms(s) without making any reference to the tenderers.
- 6. Necessary clarifications required by CSIR-NML along with the supporting documents shall have to be furnished by the tenderer within the time stipulated by the CSIR-NML. The tenderer will have to send his representative to discuss with the representative of CSIR-NML, Jamshedpur as & when required.
- 7. As per 2.2.11 of CPWD HVAC works manual, after obtaining clarifications from all the tenderer, if required CSIR-NML may modify the technical & commercial conditions, specifications and will be intimated to the tenderers whose technical bids are acceptable. In case tenderer wants to modify the price bid they can submit the same before opening of price bid as intimated by Engineer in charge. This however, may be allowed only if there is any change in specification/items by CSIR-NML.
- 8. A tenderer will not be allowed to withdraw or modify any conditions at a time after the technical bids have been accepted and the decision to open the price bid has been taken by CSIR-NML.
- 9. Envelope-2 shall be opened only of qualified bidders, on notified date & time, in the presence of tenderers or their representatives, if any. The notifications shall be available on NML Website i.e. <u>www.nmlindia.org.</u>
- 10. Tenderers must ensure that all the prints of downloaded documents should be of good quality and clearly legible. Vague /poor quality of printed documents and incomplete documents will not be accepted.
- 11. Conditional tenders & tender with use of corrections fluid, shall be rejected.

The Director, CSIR-NML, Jamshedpur reserves the right of accepting or rejecting any or all tenders or any part thereof without assigning any reason.
